Subject : Clarification of the performance of the second quarter 2024, which has changed over 20 %
in comparison to the year 2023.

To : The director of the Stock Exchange of Thailand

Ramkhamhaeng Hospital Public Company Limited would like to clarify the operation results, as follows:

1. Ramkhamhaeng Hospital Public Company Limited and its subsidiaries have the revenues of 2,511.50 million baht, decrease of 14.44 %. The reasons for the decrease are :

1.1 In the year 2024 and 2023, the revenues in Consolidated Financial Statement come form the seven companies are broken down as follow ;

1.2 In 2024, the company gains the revenue from medical equipment and supplies 156.88 million baht declining 129.25 million baht from the previous year.

1.3 In the year 2024, Ramkhamhaeng Hospital Public Company Limited receives dividend from investment

125.80 million baht, decrease of 0.43 million baht from the previous year.

1.4 In addition to the other incomes in 1.2 and 1.3 there are also the following incomes :

It can be seen that the proportion of cost of medical treatment and administration expenses / revenue of medical treatment in 2024 is slightly higher than 2023 about 0.46 % and financial cost is 2024 is higher than previous year about 27.05 million baht. In 2024, the interest market rate is higher than 2023.
